A Modest Proposal

For LGBT+ Rehabilitation and the Eradication of the Homosexual Agenda

However, through the unfortunate and inevitable passage of time, the ideals of the American public have extended well past what was originally intended. Too much has been sacrificed in the name of liberty and justice for all; after all, it is not an uncommon fact that the ‘all’ written in our Constitution was not intended for everyone.

Picture this: A man stands at a park, playing with a child in a ballerina’s uniform and tugging dolls through the grass with perfect, joyous hands. On a nearby bench, a woman sits, looking out into the greenery on which they play, sitting next to another man with his nose stuck in a book. Sounds like a wonderful family, right?

But, dear reader, look closer. The man on the bench stands up and greets the man with the child, to the horror of onlookers, with a lingering, lustful kiss. And the child, still frolicking in the grass, is not the perfect little girl everyone thought she was; instead, a little boy stands in her place. Despite valiant attempts to stifle such nefarious plans, gay people and their other overbearing companions now litter the streets of America, infecting the population like a deadly disease and spreading throughout the continent.

Although this virus has already ravaged the country and the rest of the world, it is not too late to turn us back around. Here, I propose a solution to a seemingly solutionless problem: a solution to the damage having been done to our society by gay people, who, as a whole, have contributed little and taken much from us, a solution to the propaganda being shoved in the faces of our youth, a noise to drown out the devilish whisper in the ear of all Americans who have to Obear this unimaginable burden.

First, my solution necessitates the isolation of these infected individuals. Each must to put to trial in the Homosexual Inquisition, following in the footsteps of the brave, righteous Spanish men who used such an Inquisition as a simple means by which to save their country. They will be judged by the purest embodiment of mankind, the Supreme Council of Heterosexuality. This panel will only consist of the seven most righteous, virtuous, and honorable people (such as myself) the world can find.

The punishment for each tier of homosexuals will vary as follows: the bottom tier, known to its counterparts as the “Casual Gay,” will be isolated based on the description of “owning, wearing, or aesthetically enjoying at least one of the following: beanies, flannel shirts, or clothing representative of the opposite sex.” These people are the closest to reintegration into normal society, and as such only require minimal intervention.
